- Our most important duty is the safety and wellbeing of campers. Therefore, we ask that only those who are genuinely interested in working with children apply to be a CIT. **The CIT’s assignment can be discontinued at any time.**
- CITs are expected to arrive and depart according to their schedule and complete assignments.
- Qualifying applicants will:
 - ✓ Have completed at least the 7th grade or higher by June 2024.
 - ✓ Be able to attend camp each day of the assigned weeks, Mon-Fri from 8:30am-4:30pm.
