Jessica- Good morning. I received this email response below from Steven Palmer following my response below. Obviously, his response regarding the Ranch's input on the subject of demand for additional PB courts was very surprising. Based on our past discussions (email and telephone) I was under the impression that you were supportive of the additional courts and it was more of an issue of having Tiburon add the courts b/c you felt that Belvedere had already done installed lines; ergo, additional courts should be on Tiburon's courts.

I am happy to have additional residents email you to provide their feedback on the need for more courts if you (or the joint rec board) need more data on the demand and the continued growth. Again, taking advantage of the Tiburon's plan to resurface the courts in the next month would be ideal to add the lines. I also question what would be the harm of adding PB court lines and nets to one of the Cove Courts in order to provide the flexibility for both Tennis and PB use?

As you may have heard, the members of TPC are asking the club to also initiate a project to add new dedicated PB courts given the increased demand and requests by its members. I believe this is further evidence of the demand.
